4. Payment for the Initiation Fee, sales tax and dues to next billing period will be requested upon acceptance.
5. The Gun Club is required by the State of Texas to collect sales tax of 8.25% on the Initiation Fee and dues.
6. Dues are payable on a monthly or annual basis.
7. Membership initiation fee is payable all upfront and/or by monthly or quarterly payments until paid in full.
